

MODERNIZATION OF THREE (3) UNITS PASSENGER ELEVATOR AT THE NATIONAL MUSEUM OF NATURAL HISTORY (NMNH) BUILDING (LOT 1.) MODERNIZATION OF "MP BRAND" HYDRAULIC PASSENGER ELEVATOR (1150 KGS. CAPACITY X2 STOPS)

WHEREAS, the National Museum of the Philippines (NMP), through the Bids and Awards Committee (BAC), intends to acquire, by means of Public Bidding, a bonafide merchant for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **One Million Nine Hundred Eighty Thousand Pesos (Php 1,980,000.00)** chargeable against General Fund FY 2021;

WHEREAS, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPs), NMP Website and in the BAC Bulletin Board on 20 August 2021, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA), Philippine Chamber of Commerce and Industry, National Historical Commission of the Philippines (NHCP), Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

WHEREAS, a Pre-Bidding Conference was held on 27 August 2021 at the Old Civil Service Building, Padre Burgos Street, Manila to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, the Committee conducted the Submission and Opening of Bids on 10 September 2021, at the Old Civil Service Building, Padre Burgos Street, Manila, attended and participated by two (2) bidders, namely, DEX INTERNATIONAL CO. (DEX, for brevity) and ROCKSPEED ELEVATOR & ESCALATOR CORP. (ROCKSPEED, for brevity);

WHEREAS, DEX and ROCKSPEED passed the eligibility, technical, and financial check performed by the Committee using the pass or fail non-discretionary criteria for evaluation being the DEX as a lowest calculated bid;

WHEREAS, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected DEX to Post Qualification Evaluation, being the lowest calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared DEX as post qualified and responsive to the requirement set for the aforementioned project;

WHEREAS, after the deliberation of the result of the Post Qualification Evaluation, the Chairperson, with the concurrence of the Committee members, issued a Notice of Post – Qualification to DEX;

NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby recommend that the project, **MODERNIZATION OF THREE (3) UNITS PASSENGER ELEVATOR AT THE NATIONAL MUSEUM OF NATURAL HISTORY (NMNH) BUILDING (LOT 1.) MODERNIZATION OF “MP BRAND” HYDRAULIC PASSENGER ELEVATOR (1150 KGS. CAPACITY X2 STOPS)**, be awarded to **DEX INTERNATIONAL CO.**, with a contract amount of **One Million Five Hundred Ninety-Six Thousand Two Hundred Ninety-Six Pesos (Php 1,596,296.00)**.
