SUPPLY AND DELIVERY OF SUPPLIES, MATERIALS AND EQUIPMENT UNITS FOR THE ELIZABETH Y. GOKONGWEI ETHNOGRAPHIC STONWARE RESOURCE CENTER AND VISIBLE STORAGE AT THE 5F OF THE NATIONAL MUSEUM OF ANTHROPOLOGY

WHEREAS, the National Museum of the Philippines (NMP), through the Bids and Awards Committee (BAC), intends to acquire, by means of Public Bidding, a bonafide merchant for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **One Million One Hundred Ninety-Five Thousand Five Hundred Pesos (Php 1,195,500.00)** chargeable against Gokongwei Brother Foundation, Inc. (GBFI) Donated Fund FY 2021;

WHEREAS, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS), NMP Website and in the BAC Bulletin Board on 18 August 2021, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA), Philippine Chamber of Commerce and Industry, National Historical Commission of the Philippines (NHCP), Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

WHEREAS, a Pre-Bidding Conference was held on 25 August 2021 at the Old Civil Service Building, Padre Burgos Street, Manila to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, the Committee conducted the Submission and Opening of Bids on 8 September 2021, at the Old Civil Service Building, Padre Burgos Street, Manila, attended and participated by lone bidder, namely, IKF HOME FURNISHING & OFFICE FURNITURE (IKF, for brevity);

WHEREAS, IKF passed the eligibility, technical, and financial check performed by the Committee using the pass or fail non-discretionary criteria for evaluation;

WHEREAS, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected IKF to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared IKF as post qualified and responsive to the requirement set for the aforementioned project;

WHEREAS, after the deliberation of the result of the Post Qualification Evaluation, the Chairperson, with the concurrence of the Committee members, issued a Notice of Post – Qualification to IKF;


