**PROCUREMENT OF ICT EQUIPMENT AND PERIPHERALS**  
**LOT 4: PROCUREMENT OF ICT SUPPLIES AND PERIPHERALS**

**WHEREAS**, the National Museum of the Philippines, through the Bids and Awards Committee (BAC), intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **One Million Nine Hundred Ninety-Five Thousand Pesos (Php 1,995,000.00)** chargeable against General Fund FY 2022;

**WHEREAS**, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPs) and in the BAC Bulletin Board on 22 February 2022, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, seven (7) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Institute of Civil Engineers (PICE), United Architects of the Philippines (UAP), Philippine Chamber and Industry Plaza, Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

**WHEREAS**, a Pre-Bidding Conference was held on 2 March 2022 at the Old Civil Service Building, Padre Burgos Street, Manila to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

**WHEREAS**, the Committee conducted the Submission and Opening of Bids on 16 March 2022, at the Old Civil Service Building, Padre Burgos Street, Manila, attended and participated by a lone bidder, namely Jarhens Trading;

**WHEREAS**, Jarhens Trading passed the technical, and financial components based on RA 9184 as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;

**WHEREAS**, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected Jarhens Trading to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

**WHEREAS**, the TWG, after thorough and proper evaluation, confirmed and declared Jarhens Trading as post qualified and responsive to the requirement set for the aforementioned project;

**NOW, THEREFORE**, the members of the Bids and Awards Committee hereby recommend as we hereby recommend that the project, **PROCUREMENT OF ICT EQUIPMENT AND PERIPHERALS LOT 4: PROCUREMENT OF ICT SUPPLIES AND PERIPHERALS**, be awarded to Jarhens Trading, with a contract amount of **One Million Seven Hundred Seventeen Thousand Pesos (Php 1,717,000.00)**.
