**PROCUREMENT OF SECURITY SERVICES AT CENTRAL AND REGIONAL OFFICES OF
THE NATIONAL MUSEUM OF THE PHILIPPINES FY 2022**

WHEREAS, the National Museum of the Philippines (NMP), through the Bids and Awards Committee (BAC), intends to acquire, by means of Public Bidding, a bonafide merchant for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **Seventy Million Nine Hundred Nineteen Thousand One Hundred Fifty-Four Pesos (Php 70,919,154.00)** chargeable against General Fund FY 2022;

WHEREAS, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPs), NMP Website and in the BAC Bulletin Board on 22 December 2021, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA), Philippine Chamber of Commerce and Industry, National Historical Commission of the Philippines (NHCP), Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

WHEREAS, a Pre-Bidding Conference was held on 19 January 2022 at the Old Civil Service Building, Padre Burgos Street, Manila to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, the Committee conducted the Submission and Opening of Bids on 9 February 2022, at the Old Civil Service Building, Padre Burgos Street, Manila, attended and participated by lone bidder, namely JSL Security Agency Inc.;

WHEREAS, JSL Security Agency Inc. passed the eligibility, technical, and financial check performed by the Committee using the pass or fail non-discretionary criteria for evaluation with a bid amount to **Seventy Million Nine Hundred Nineteen Thousand One Hundred Fifty-Four Pesos (Php 70,919,154.00)** as read;

WHEREAS, the Committee thru its Technical Working Group, conducted a detailed evaluation of bids and found an error in the computation of its bid offer;

WHEREAS, after proper recomputation, the amount of the proposed bid was adjusted from **Seventy Million Nine Hundred Nineteen Thousand One Hundred Fifty-Four Pesos (Php 70,919,154.00)** to **Seventy Million Nine Hundred Fifteen Thousand Three Hundred Seventy-Four Pesos (Php 70,915,374.00)**;



WHEREAS, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected JSL Security Agency Inc. to Post Qualification Evaluation, being the single calculated bid;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared JSL Security Agency Inc. as post qualified and responsive to the requirement set for the aforementioned project;

WHEREAS, after the deliberation of the result of the Post Qualification Evaluation, the Chairperson, with the concurrence of the Committee members, issued a Notice of Post – Qualification to JSL Security Agency Inc.;

NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby recommend that the project, **PROCUREMENT OF SECURITY SERVICES AT CENTRAL AND REGIONAL OFFICES OF THE NATIONAL MUSEUM OF THE PHILIPPINES FY 2022**, be awarded to **JSL Security Agency Inc.**, with a contract amount of **Seventy Million Nine Hundred Fifteen Thousand Three Hundred Seventy-Four Pesos (Php 70,915,374.00)**.


