Description

1. The NATIONAL MUSEUM OF THE PHILIPPINES, through the National Expenditure Program FY 2023 intends to apply the sum and project indicated below, being the ABC to payment under the contract for each lot.

1 Procurement of Janitorial Services for the National Museum of the Philippines (NMP) Complex for FY 2023 - ABC: Php 29,594,789.70

2 Procurement of Janitorial Services for the NMP Regional Area, Site Museums and Satellite Offices (RASMSO) and the Kalinga Site Project for FY 2023 - ABC: Php 7,774,435.08

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The NATIONAL MUSEUM OF THE PHILIPPINES now invites bids for the above Procurement Project. Delivery of the Goods and Services is required Twelve (12) Months. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the NATIONAL MUSEUM OF THE PHILIPPINES BIDS AND AWARDS COMMITTEE and inspect the Bidding Documents at the address given below from Mondays – Fridays at 9:30 A.M.- 3:30 P.M.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on 21 December 2022, 10:30 A.M. at 2nd Floor, BAC Room, North Annex of the National Museum of Fine Arts Building (Motorpool) Padre Burgos Street, Manila 1000. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
