INVITATION TO BID FOR

Supply and Delivery of Various Maintenance Materials - FY 2023

The NATIONAL MUSEUM OF THE PHILIPPINES, through the NEP FY 2023 intends to apply the sum of One Million Two Hundred Fifty Thousand Pesos (Php 1,250,000.00) being the ABC to payments under the project mentioned above. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NATIONAL MUSEUM OF THE PHILIPPINES now invites bids for the above Procurement Project. Delivery of the Goods and Services is required within 1st, 2nd, 3rd, and 4th quarter of the year 2023. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No.
