Item No. 1 : Clarifications;

1. Joint Venture Agreement will be accepted subject to the requirements provided in 2016 IRR of RA 9184
2. Bid proposal must be based on PADPAO rate as agreed upon by all prospective bidders, who attended the pre-bidding conference dated December 6, 2022.

As manifested in the Technical Specification the contract cost shall be fixed and shall not be adjusted during the contract implementation except in the following cases.

- a. Increase in minimum daily wage (pursuant to new wage order)
 - b. Increase in other statutory benefits such as SSS, PhilHealth, HDMF etc.,
3. Additional set of parameters being required by the National Museum as part of the Technical document is in accordance with RA 9184 and its 2016 Implementing Rules and Regulation.

Please see 4.1, 4.2, and 4.3, of Appendix 23 (Guidelines on the procurement of Security & Janitorial Services).

The said additional set of parameters is expressly provided in Section VII of the Technical Specification of the National Museum bidding documents.
