The NATIONAL MUSEUM OF THE PHILIPPINES, through the NEP FY 2023 intends to apply the sum of One Million One Hundred Seventy-Nine Thousand (Php 1,179,620.00) being the ABC to payments under the project mentioned above. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NATIONAL MUSEUM OF THE PHILIPPINES now invites bids for the above Procurement Project. Delivery of the Goods and Services is required within Twelve (12) Months. Bidders should have completed, within five (5) years fron the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). from
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from the NATIONAL MUSEUM OF THE PHILIPPINES BIDS AND AWARDS COMMITTEE and inspect the Bidding Documents at the address given below from Mondays Fridays from 9:00 A.M.- 3:30 P.M.
