1. The National Museum of the Philippines, through the General Fund FY 2023 intends to apply the sum of Eighty-Four Million Eight Hundred Forty-Five Thousand Nine Hundred Ninety-Six Pesos and Eighty Centavos (PHP 84,845,996.80), being the Approved Budget for the Contract (ABC), to payments under the contract indicated above. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The National Museum of the Philippines now invites bids for the above Procurement Project. Completion of the Works is required within Three Hundred Sixty-Five (365) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders)
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the National Museum of the Philippines Bids and Awards Committee and inspect the Bidding Documents at the address given below from Mondays - Fridays at 9:30 A.M. to 3:30 P.M.
5. A complete set of Bidding Documents may be acquired by interested bidders on 4 February 2023, from the given address below and upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand Pesos (PHP 50,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, or through electronic means.
6. Pre-Bid Conference shall be on 15 February 2023, 10:30 A.M. at the given address below, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before 1 March 2023, at 10:30 A.M. LATE BIDS SHALL NOT BE ACCEPTED.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on 1 March 2023, at 10:30 A.M. at given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The National Museum of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
