**LOT # 1: PROCUREMENT OF JANITORIAL SERVICES FOR THE NATIONAL MUSEUM  
OF THE PHILIPPINES (NMP) COMPLEX PROJECT FOR FY 2023**

**WHEREAS**, the National Museum of the Philippines, through the Bids and Awards Committee (Committee), intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **Twenty-Eight Million Eight Hundred Nineteen Thousand One Hundred Eighty-Six Pesos and Forty-Four Centavos (Php 28,819,186.44)** chargeable against General Fund FY 2023;

**WHEREAS**, on 28 November 2022 an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPs) and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, five (5) observers from various government offices and private organizations were invited to witness the bidding process, *viz.* Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber and Industry Plaza, Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

**WHEREAS**, on 06 December 2022 a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

**WHEREAS**, on 21 December 2022 the Committee conducted the Submission and Opening of Bids, attended and participated by a lone bidder, namely Euro Janitorial Services & Co.;

**WHEREAS**, Euro Janitorial Services & Co. passed the technical, and financial components based on RA 9184 as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;

**WHEREAS**, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected Euro Janitorial Services & Co. to Post Qualification Evaluation, being the lowest calculated bid after the bid evaluation conducted by the Committee;

**WHEREAS**, the TWG, after thorough and proper evaluation, confirmed and declared Euro Janitorial Services & Co. as post qualified and responsive to the requirement set for the aforementioned project;

**NOW, THEREFORE**, the members of the Bids and Awards Committee hereby recommend as we hereby **RECOMMENDS** that the project, **Lot # 1: Procurement of Janitorial Services for the National Museum of the Philippines (NMP) Complex for FY 2023**, be awarded to **Euro Janitorial Services & Co.**, with a contract amount of **Twenty-Five Million Sixty-Nine Thousand Four Hundred Twenty-Six Pesos & Forty-Four Centavos (Php 25,069,426.44)**.


