**CONTRACT AGREEMENT**

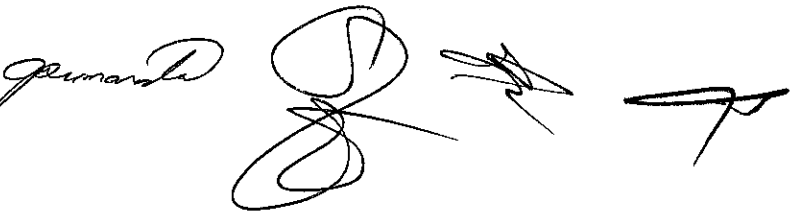
THIS AGREEMENT made the 3<sup>rd</sup> day of March 2023 between **NATIONAL MUSEUM OF THE PHILIPPINES, National Museum Complex, Rizal Park, Manila, 1000, Philippines** (hereinafter called "the MUSEUM") and **MARELCO TRADING CORP., Room 206 Tres Hermanas Bldg. 967 Quezon Ave. cor. Roosevelt Avenue, Quezon City** (hereinafter called "the SUPPLIER"):

WHEREAS, the MUSEUM invited Bids for certain goods and ancillary services, viz., particularly *Procurement of Various Maintenance Materials for FY 2023 (Supply and Delivery)* and has accepted a Bid by the SUPPLIER for the supply of those goods and services in the sum of **Nine Hundred Ninety-Two Thousand Five Hundred Forty-Four Pesos (PHP 992,544.00)** (hereinafter called "the Contract Price").

WHEREAS the drafting and preparation of the Contract was conducted on February 23, 2023.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. Terms of Reference and Scope of Works;
    - iv. General and Special Conditions of Contract; and
    - v. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Performance Security;
  - v. Notice of Award of Contract; and the Bidder's conforme thereto; and



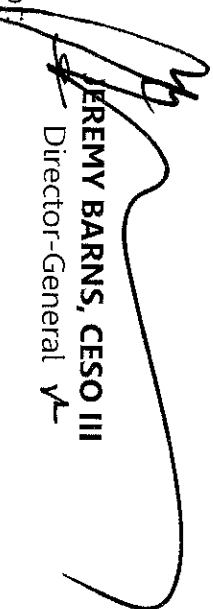
v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Nine Hundred Ninety-Two Thousand Five Hundred Forty-Four Pesos (PHP 992,544.00)** or such other sums as may be ascertained, **Procurement of Various Maintenance Materials for FY 2023 (Supply and Delivery)** in accordance with his/her/its Bid.

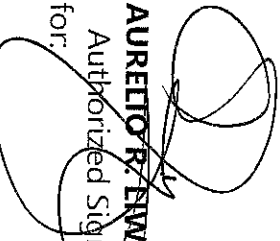
4. The **NATIONAL MUSEUM OF THE PHILIPPINES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

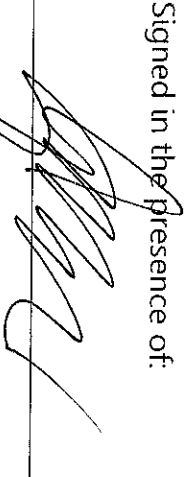

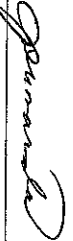
