The National Museum of the Philippines, through the General Fund FY 2023 intends to apply the sum of One Hundred Ninety-Nine Million Nine Hundred Forty-Five Thousand Pesos (PHP 199,945,000.00), being the Approved Budget for the Contract (ABC), to payments under the contract indicated above. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The National Museum of the Philippines now invites bids for the above Procurement Project. Completion of the Works is required within Four Hundred Fifty (450) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders)
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the National Museum of the Philippines Bids and Awards Committee and inspect the Bidding Documents at the address given below from Mondays - Fridays at 9:30 A.M. to 3:30 P.M.
5. A complete set of Bidding Documents may be acquired by interested bidders on 17 May 2023, from the given address below and upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand Pesos (PHP 50,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, or through electronic means.
6. Pre-Bid Conference shall be on 25 May 2023, 10:30 A.M. at the 2/F Executive Building, Municipal Plaza T.Moliba St., Baler Aurora, which shall be open to prospective bidders.
