## Description

The NATIONAL MUSEUM OF THE PHILIPPINES (NMP), through the General Fund FY 2023 (Hibla ng Lahing Filipino Program) intends to apply the sum of Three Million Six Hundred Seventy-Four Thousand Five Hundred Twenty-Seven Pesos and Twenty-Five Centavos (PHP 3,674,527.25) being the ABC to payments under the contract for the project mentioned above. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NMP now invites bids for the above Procurement Project. Delivery of the Goods and Services is required Ninety (90) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Biddin criterion Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/faili" terion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 91 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 앜
