

RESOLUTION NO. 2023-35

**Exhibition and Fit-Out of Various National Museum of the Philippines
Central and Regional Sites – Lot #1: Furniture and Fixture (Supply and Delivery)**

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee, intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is Three Million Pesos (Php 3,000,000.00) chargeable against General Fund FY 2023;

WHEREAS, on 31 May 2023, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPs) and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry (PCCI), Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

WHEREAS, on 8 June 2023, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, on 23 June 2023, the Committee conducted the Submission and Opening of Bids, attended and participated by a lone bidder, namely DESIGN EXCELLENCE HOME AND OFFICE SYSTEM CO.;

WHEREAS, DESIGN EXCELLENCE HOME AND OFFICE SYSTEM CO. passed the technical and financial components based on RA 9184 as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;

WHEREAS, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected DESIGN EXCELLENCE HOME AND OFFICE SYSTEM CO. to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared DESIGN EXCELLENCE HOME AND OFFICE SYSTEM CO. as post-qualified and responsive to the requirement set for the aforementioned project;

NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby **RECOMMEND** that the project, “**Exhibition and Fit-Out of Various National Museum of the Philippines Central and Regional Sites– Lot #1: Furniture and Fixture (Supply and Delivery)**”, be awarded to DESIGN EXCELLENCE HOME AND OFFICE SYSTEM CO., with a contract amount of Two Million Nine Hundred Eighty-Four Thousand Four Hundred Fifty Pesos (Php 2,984,450.00).


