- Department of Trade and Industry (DTI) Registration Certificate for Sole Proprietorship;
- Securities and Exchange Commission Registration Certificate for Partnership and Corporation;
- Tax Clearance issued by BIR;
- Company Profile for Partnership and Corporation;
- Certified true copy of Two (2) valid identification cards for owner president / general manager for Partnership and Corporations;
- Authorization under oath for representative of owner or president / general Manager with certified true copy valid identification card; and
- Certificate of Site Inspection.




b. 2nd Envelope containing the financial components, including:

- Bid Tender / Quotation (3 original copies); and
- Bid Bond (cash) equivalent to 10% of the total bid price

The NMP reserves the right to reject any of all bids thereof, waive any informality found therein or accept such bids or to award to any interested party/bidder whose considered most advantageous to the NMP and/or the Government.

The awardee must pay the full amount for the awarded items in cash or by manager's check, with 10% Performance Bond (cash) equivalent to the total bid price payable to the National Museum of the Philippines, within seven (7) days from receipt of the Notice of Award. Failure to make the full payment within the specified period will result in cancellation of award and forfeiture of the bond in favor of the NMP.
