



**PROCUREMENT OF VARIOUS LIGHTING FIXTURE AND VARIOUS EXHIBITION  
MATERIALS FOR GALLERIES FY 2023 (SUPPLY AND DELIVERY)  
LOT #2: Various Exhibition Materials for Galleries FY 2023**

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee, intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is One Million One Hundred Eighty-Two Thousand Eight Hundred Twenty Pesos (Php 1,182,820.00) chargeable against General Fund FY 2023;

WHEREAS, on 07 August 2023, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS) and in the BAC Bulletin Board, pursuant to *Sec. 21 of the 2016 Revised IRR of R.A. 9184*;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry (PCCI), Institute of Politics & Governance, Inc. (IPG), and Museum Employees Organization (MUSEO);

WHEREAS, on 15 August 2023, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, on 07 September 2023, the Committee conducted the Submission and Opening of Bids, attended and participated by a lone bidder, namely RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE;

WHEREAS, RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE; passed the technical and financial components based on *RA 9184* as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;

WHEREAS, pursuant to *Section 34, Rule X of the 2016 Revised IRR of R.A. 9184*, the Technical Working Group (TWG) subjected RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE as post-qualified and responsive to the requirement set for the aforementioned project;

NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby RECOMMEND that the project, "**PROCUREMENT OF VARIOUS LIGHTING FIXTURE AND VARIOUS EXHIBITION MATERIALS FOR GALLERIES FY 2023 (SUPPLY AND DELIVERY) LOT #2: Various Exhibition Materials for Galleries FY 2023**", be awarded to **RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE** with a contract amount of **One Million One Hundred Thousand Pesos (Php1,100,000.00)**.


