## Description

- 1. The National Museum of the Philippines, through the General Fund for F.Y. 2023 intends to apply the sum of Two Million Nine Hundred Sixty-Three Thousand Pesos (PHP 2,963,000.00) being the ABC to payments under the contract for Shipping/Transportation (Door-to-Door) and Proper Handling of Collection from the FASGI, Los Angeles, USA to the National Museum of the Philippines, Manila, PH, with identification number NMPBAC-PB-2023-10-03. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Museum of the Philippines now invites bids for the above Procurement Project. Delivery of the Goods is required by Twenty (20) Calendar Days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" iterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 91 9184.

"Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183."

- 4. Prospective Bidders may obtain further information from National Museum of the Philippines and inspect the Bidding Documents at the address given below during Mondays to Fridays, from 9:30 a.m. to 3:30 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 11, 2023, from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PHP 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- The National Museum of the Philippines will hold a Pre-Bid Conference on October 20, 2023, at 10:30 AM at 2nd sor BAC Room North Annex (Motorpool) Building which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated 3
- Bid opening shall be on November 6, 2023, at 10:30 AM at the given address below. Bids will be opened in the

presence of the bidders' representatives who choose to attend the activity.
