

RESOLUTION NO. 2023-62

**SHIPPING / TRANSPORTATION (DOOR-TO-DOOR) AND PROPER HANDLING OF COLLECTION
FROM THE FASGI LOS ANGELES USA TO THE NATIONAL MUSEUM OF THE PHILIPPINES
MANILA PH**

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee, intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is Two Million Nine Hundred Sixty-Three Thousand Pesos (Php 2,963,000.00) chargeable against General Fund FY 2023;

WHEREAS, on 11 October 2023, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS) and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry (PCCI), Institute of Politics & Governance, Inc. (IPG), and Museum Employees Organization (MUSEO);

WHEREAS, on 20 October 2023, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, on 06 November 2023, the Committee conducted the Submission and Opening of Bids, attended and participated by a lone bidder, namely LIBCAP SUPER EXPRESS CORPORATION;

WHEREAS, LIBCAP SUPER EXPRESS CORPORATION, passed the technical and financial components based on RA 9184 as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;


WHEREAS, pursuant to *Section 34, Rule X of the 2016 Revised IRR of R.A. 9184*, the Technical Working Group (TWG) subjected LIBCAP SUPER EXPRESS CORPORATION to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared LIBCAP SUPER EXPRESS CORPORATION as post-qualified and responsive to the requirement set for the aforementioned project;

NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby **RECOMMEND** that the project, "**SHIPPING / TRANSPORTATION (DOOR-TO-DOOR) AND PROPER HANDLING OF COLLECTION FROM THE FASGI LOS ANGELES USA TO THE NATIONAL MUSEUM OF THE PHILIPPINES MANILA PH**", be awarded to namely **LIBCAP SUPER EXPRESS CORPORATION** with a contract amount of **Two Million Eight Hundred Forty-Four Thousand Pesos (Php 2,844,000.00)**.


