



RESOLUTION NO. 2023-66

**FABRICATION, PRINTING AND INSTALLATION OF DISPLAY SYSTEMS FOR THE HIBLA  
NG LAHING FILIPINO REGIONAL GALLERY AT THE NATIONAL MUSEUM OF THE  
PHILIPPINES – DAVAO REGIONAL MUSEUM IN DAVAO CITY**

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee, intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **Three Million Seven Hundred Ninety Thousand Pesos – (Php 3,790,000.00)** chargeable against General Fund FY 2023;

WHEREAS, on 25 October 2023, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPs) and in the BAC Bulletin Board, pursuant to *Sec. 21 of the 2016 Revised IRR of R.A. 9184*;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry (PCCI), Institute of Politics & Governance, Inc. (IPG), and Museum Employees Organization (MUSEO);

WHEREAS, on 08 November 2023, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, on 24 November 2023, the Committee conducted the Submission and Opening of Bids, attended and participated by a lone bidder, namely Nikko Metal Works Corporation;

WHEREAS, Nikko Metal Works Corporation passed the technical, and financial components based on *RA 9184* as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;

WHEREAS, pursuant to *Section 34, Rule X of the 2016 Revised IRR of R.A. 9184*, the Technical Working Group (TWG) subjected Nikko Metal Works Corporation to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared Nikko Metal Works Corporation as post-qualified and responsive to the requirement set for the aforementioned project;


NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby **RECOMMEND** that the project, **FABRICATION, PRINTING AND INSTALLATION OF DISPLAY SYSTEMS FOR THE HIBLA NG LAHING FILIPINO REGIONAL GALLERY AT THE NATIONAL MUSEUM OF THE PHILIPPINES – DAVAO REGIONAL MUSEUM IN DAVAO CITY**, be awarded to **Nikko Metal Works Corporation**, with a contract amount of **Three Million Seven Hundred Eighty-Nine Thousand Nine Hundred Fifty Pesos – (Php3,789,950.00)**.


