



**CONTRACT AGREEMENT**

THIS AGREEMENT made this 15 ~~MAR~~ <sup>MAR</sup> ~~2024~~ <sup>2024</sup> day of \_\_\_\_\_ 2024 between **NATIONAL MUSEUM OF THE PHILIPPINES, National Museum Complex, Rizal Park, Manila, 1000, Philippines** (hereinafter called “the MUSEUM”) of the one part and **LIBCAP SUPER EXPRESS CORPORATION, LIBCAP Commercial Building, Quintin Salas, Jaro, Iloilo City** (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Museum invited Bids for certain goods and ancillary services, particularly **Shipping/Transportation (Door-to-Door) and Proper Handling of PCNY Collection from the National Museum of the Philippines – Cebu to Philippine Center New York (USA)**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eight Million Three Hundred Seventy-Five Thousand Thirty-Six Pesos (PHP 8,375,036.00)** (hereinafter called “the Contract Price”).

WHEREAS, the drafting and preparation of the Contract was conducted on **March 11, 2024**.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
  - ii. Schedule of Requirements;
  - iii. Technical Specifications;
  - iv. General and Special Conditions of Contract; and Supplemental or Bid Bulletins, if any
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**






