RESOLUTION No. 2024-16

REHABILITATION OF ELECTRICAL SYSTEM AT NMP BUTUAN

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee (Committee), intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **Two Million Two Hundred Eighty-Four Thousand Two Hundred Sixty-Three Pesos and Eight Centavos (PHP 2,284,263.08)** chargeable against the General Fund for F.Y. 2024

WHEREAS, on 03 March 2024, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS) and in the BAC Bulletin Board, pursuant to *Sec. 21 of the 2016 Revised IRR of R.A. 9184*;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, *viz*: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber and Commerce Industry (PCCI), Institute of Politics and Governance (IPG), and Museum Employees Organization (MUSEO);

WHEREAS, on 11 March 2024, a Pre-Bidding Conference was held at the 2nd Floor BAC Room, North Annex (Motorpool), Padre Buros Street, Manila to discuss all matters pertaining to the aforementioned project, *i.e.* Terms of Reference, Scope of Work, Bidding Documents, and others;

WHEREAS, on 01 April 2024, the schedule opening of bids, no bids were submitted nor received by the Committee;

WHEREAS, Sec. 35.1 (a) of the 2016 Revised IRR of R.A. 9184 provides for the declaration of failure of bidding when no bids are received;

NOW THEREFORE, WE, the members of the Bids and Awards Committee, hereby resolve as we hereby **RESOLVED** to recommend for the approval to the Head of the Procuring Entity, the following;

1. Declaration of Failure of Bidding for the project **REHABILITATION OF ELECTRICAL SYSTEM AT NMP BUTUAN** in accordance with Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184;
2. Conduct mandatory review on the terms, specifications, and cost estimates of the project, if applicable;
3. Reposting/Readvertisement of the Invitation to Bid pursuant to the rules provided in the 2016 Revised IRR of R.A. 9184.




