INVITATION TO BID

Restoration and Development of NMP Museums and
Declared/Associated Heritage Sites in the Visayas (Repair and
Maintenance at National Museum of the Philippines – Iloilo)

1. The **National Museum of the Philippines**, through the **General Appropriations Act (GAA)** for **F.Y. 2025** intends to apply the sum of **Five Million One Hundred Thousand Pesos (PHP 5,100,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Restoration and Development of NMP Museums and Declared/Associated Heritage Sites in the Visayas (Repair and Maintenance at National Museum of the Philippines – Iloilo)** with identification number **NMPBAC-PB-2025-03-05**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The National Museum of the Philippines now invites bids for the above Procurement Project. Completion of the Works is required within Ninety (90) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the **National Museum of the Philippines** Bids and Awards Committee and inspect the Bidding Documents at the address given below from **Mondays - Fridays at 9:30 A.M. to 3:30 P.M.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **April 3, 2025** from given address and website/s below and upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PHP 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

6. The National Museum of the Philippines will hold a **Pre-Bid Conference on April 10, 2025, 09:30 A.M. at 2nd Floor North Annex Building BAC Office, National Museum of the Philippines Fine Arts Building (Motorpool)**, Padre Burgos Street, Manila, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, **late bids shall not be accepted.**
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14.**

9. Bid opening shall be on **April 28, 2025**, at **09:30 A.M.** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
