

**Upgrading of Airconditioning System at South-West Portion of NMFA Main Building**

**WHEREAS**, the National Museum of the Philippines, through the Bids and Awards Committee (Committee), intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **Sixteen Million Pesos (PHP16,000,000.00)** chargeable against General Fund FY 2025;

**WHEREAS**, on 14 May 2025, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS), National Museum of the Philippines' Website and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry (PCCI); Institute of Politics and Governance, Inc., and; Museum Employees Organization (MUSEO);

**WHEREAS**, on 21 May 2025, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents, and others;

**WHEREAS**, on 04 June 2025, the Committee conducted the Submission and Opening of Bids, attended and participated by five (5) bidders, namely:

1. **Trademaster Resources Corporation**
2. **Bouyant Industrial Systems Inc.**
3. **Coffel Aire Industries Incorporated**
4. **Innovalite Inc.**
5. **ACMI Office Systems Phils Inc.**

**WHEREAS**, **Trademaster Resources Corporation** passed the technical, and financial components based on RA 9184 as checked by the Committee using the pass or fail non-discretionary criteria for evaluation;

**WHEREAS**, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected **Trademaster Resources Corporation** to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

**WHEREAS**, the TWG, after thorough and proper evaluation, the TWG confirmed and declared **Trademaster Resources Corporation** as post-qualified and responsive to the requirement set for the aforementioned project;

**NOW, THEREFORE**, the members of the Bids and Awards Committee hereby recommend as we hereby **RECOMMEND**, that the project **Upgrading of Airconditioning System at South-**

**West Portion of NMFA Main Building** be awarded to **Trademaster Resources Corporation**, with a contract amount of **Nine Million Six Hundred Ninety-Eight Thousand Eight Hundred Eighty-Nine Pesos (PHP 9,698,889.00)**.


