RESOLUTION NO. 2025-052

RESOLUTION DECLARING 1st FAILURE OF BIDDING FOR THE PROJECT: SUPPLY AND DELIVERY OF VARIOUS CONSERVATION MATERIALS, ARCHIVAL TOOLS AND CHEMICALS FOR CENTRAL NATIONAL MUSEUM OF THE PHILIPPINES F.Y. 2025

WHEREAS, the National Museum of the Philippines (NMP), through the Bids and Awards Committee (Committee), intends to acquire, by means of Public Bidding, a bona fide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **One Million Five Hundred Seventy Thousand pesos (PHP 1,570,000.00)** chargeable against the General Fund for Fiscal Year 2025;

WHEREAS, on 16 April 2025 an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS), NMP Website, and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry (PCCI), Institute of Politics & Governance, Inc., and Museum Employees Organization (MUSEO);

WHEREAS, on 24 April 2025, a Pre-Bidding Conference was held, to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents and others;

WHEREAS, on 09 May 2025, an Opening of Bids was scheduled which was no bidder in attendance;

WHEREAS, on *Section 35.1(a), Rule X of the 2016 Revised IRR of RA 9184*;

"Section 35.1. The BAC shall declare the bidding a failure when:

a) No bids are received;

b) All prospective bidders are declared ineligible;

c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or

d) xxx xxxx (Emphasis supplied)

NOW THEREFORE, in view of the foregoing, we, the members of the Bids and Awards Committee, hereby resolved as we hereby **RESOLVED** to recommend for approval of the Head of the Procuring Entity, the following;

1. to **DECLARE the 1st Failure of Bidding for the SUPPLY AND DELIVERY OF VARIOUS CONSERVATION MATERIALS, ARCHIVAL TOOLS AND CHEMICALS FOR CENTRAL NATIONAL MUSEUM OF THE PHILIPPINES F.Y. 2025** in accordance with *Section 35.1, Rule X of the 2016 Revised IRR of RA 9184*;

2. to **RECOMMEND** the mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates of the project, if applicable;
3. Reposting / Re-advertisement of the Invitation to Bid pursuant to the rules provided in the 2016 Revised IRR of R.A. 9184;


