

Exhibitions and Fit-Out of Various National Museum of the Philippines - Central and Regional Sites - MAPPING THE PHILIPPINE ARCHIPELAGO THROUGH CARTOGRAPHY AT NMP CEBU, INSURANCE EXPENSES, TRANSPORTATION AND DELIVERY EXPENSES

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee, intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is **Four Million Five Hundred Eighty Five Thousand Pesos (Php 4,585,000.00)** chargeable against General Fund FY 2025;

WHEREAS, on **20 May 2025** an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS), National Museum of the Philippines Website and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, viz: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber and Industry Plaza, Institute of Politics & Governance, Inc., Museum Employees Organization (MUSEO);

WHEREAS, on **9 June 2025**, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents, and others;

WHEREAS, on **26 May 2025**, the Committee conducted the Submission and Opening of Bids, attended and participated by lone bidder **Nikko Metal Works Corporation**;

WHEREAS, **Nikko Metal Works Corporation** passed the technical, and financial components based on RA 9184 as checked by the Committee using the "pass or fail" non-discretionary criteria for evaluation;

WHEREAS, pursuant to Section 34, Rule X of the 2016 Revised IRR of R.A. 9184, the Technical Working Group (TWG) subjected **NIKKO METAL WORKS CORPORATION** to Post Qualification Evaluation, being the single calculated bid after the bid evaluation conducted by the Committee;

WHEREAS, the TWG, after thorough and proper evaluation, confirmed and declared **NIKKO METAL WORKS CORPORATION** as post-qualified and responsive to the requirement set for the aforementioned project;
