- AWARDEE, ALPHA ONE EVENTS AND PROMOTIONS MANAGEMENT INCORPORATED, shall be responsible for the source(s) of its supplies/ materials/equipment and shall make deliveries in accordance with agreed schedule, quality and specifications stated in the Purchase Order (P.O)
- 3.
