Resolution Recommending Award for the Project Restoration and Development of NMP Museums and Declared/Associated Heritage Sites in the Visayas (Restoration and Site Development of the Watchtower – Belfry of the Cathedral of Sta. Catalina De Alejandria in Dumaguete City, Negros Oriental, Phase II)

WHEREAS, the National Museum of the Philippines (NMP), through the Bids and Awards Committee (BAC), intends to acquire service of a bonafide contractor with technical and financial capability, by means of Negotiated Procurement under NMP Resolution No. 2025-039 (please see copy attached) in accordance with Section 53.4 of the Implementing Rules and Regulations, R.A. 9184 (Adjacent or Contiguous) to undertake the above-mentioned project;

WHEREAS, the Approved Budget for the Contract (ABC) is Six Million Pesos (PHP6,000,000.00) chargeable against Continuing Fund of F.Y. 2024 under Capital Outlay (CO) – Buildings Outlays;

WHEREAS, the Bids and Awards Committee commenced the negotiations for this project through a letter to 401 DEVELOPMENT AND CONSTRUCTION CORP. dated 11 June 2025;

WHEREAS, the NIMPBAC conducted a thorough evaluation and review on the documents submitted by 401 DEVELOPMENT AND CONSTRUCTION CORP., including the conditions provided for in paragraph 4, (Annex "H") of the 2016 Revised IRR of RA 9184 as follows:

- i. Original contract is the result of a Competitive Bidding;

- iii. It is within the contracting capacity of the contractor/consultant considering the legal, technical (e.g., PCAB license, SLCC) and financial (e.g., NFCC for the contiguous project) requirements for eligibility;
