Lot 2: Preventive Maintenance of AV Equipment

WHEREAS, the National Museum of the Philippines, through the Bids and Awards Committee (Committee), intends to acquire, by means of Public Bidding, a bonafide contractor for the project mentioned above;

WHEREAS, the Approved Budget for the Contract (ABC) is Six Hundred Thousand Pesos (PHP 600,000.00) chargeable against General Fund FY 2024;

WHEREAS, on 3 May 2025, an Invitation to Bid was posted and published in the Philippine Government Electronic Procurement System (PhilGEPS), National Museum of the Philippines Website and in the BAC Bulletin Board, pursuant to Sec. 21 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, five (5) observers from various government offices and private organizations were invited to witness the bidding process, *viz*: Commission on Audit (COA); National Historical Commission of the Philippines (NHCP), Philippine Chamber of Commerce and Industry, Institute of Politics and Governance, and Museum Employees Organization (MUSEO);

WHEREAS, on 14 May 2025, a Pre-Bidding Conference was held to discuss all matters pertaining to the aforementioned project, i.e. Terms of Reference, Scope of Work, Bidding Documents, and others;

WHEREAS, on 28 May 2025, the Committee conducted the Submission and Opening of Bids, attended and participated by two (2) bidders, namely:

- (1) Westco Electrical & Equipment Corp., (WESTCO) and;
- (2) Connexia Technology Inc. (CONNEXIA)

WHEREAS, only WESTCO passed the technical, and financial components based on RA 9184 as checked by the Committee using the "pass or fail" non-discretionary criteria for evaluation;

WHEREAS, CONNEXIA has failed to pass the non-discretionary criteria due to the expired validity of the PhilGEPS Platinum Membership.

WHEREAS, the TWG subjected WESTCO being the Single Calculated Bid to Post-Qualification Evaluation;

WHEREAS, after thorough and proper evaluation, the TWG confirmed and declared **Westco Electrical & Equipment Corp.** as post-qualified and responsive to the requirement set for the aforementioned project;

NOW, THEREFORE, the members of the Bids and Awards Committee hereby recommend as we hereby RECOMMEND that the project, Lot 2: Preventive Maintenance of AV Equipment, be awarded to Westco Electrical & Equipment Corp., with a contract amount of Five Hundred Ninety-Eight Thousand Pesos (PHP 598,000.00).
